## Site Steward Program Evolves

The Cascadia Marine Trail (CMT) Site Steward Program is a long-standing volunteer effort to maintain a water trail that spans a couple thousand miles of shoreline. Site Stewards monitor campsites with the perspective of the paddlers who use the sites and are trained to evaluate the function and features of the campsite. Four essential features define CMT sites: access to and from the water, a place to camp, restroom facilities, and identifying signage. In addition, many sites feature kayak racks, fire pits, picnic tables, and running water. Site Stewards monitor and report the condition of CMT facilities at least two times a year, conduct litter clean up, and provide up-keep to signage. Stewards may be called upon to advocate for the Cascadia Marine Trail by attending public meetings, submitting comments to government agencies, and serving as a liaison between WWTA and the public.

Traditionally, Site Stewards have each adopted a particular campsite and committed to monitor it several times a year. It was not uncommon to have a "waiting list" for a particular campsite, as would-be Stewards waited their turn to volunteer. Meanwhile, the level of reporting varied from site to site, steward to steward.

WWTA is re-organizing the Site Steward Program for 2009. No longer will Stewards be assigned to particular campsites. Current Stew-

ards are welcomed to continue reporting on their long-adopted sites, but will be encouraged to report as they visit different Cascadia Marine Trail sites. This will allow WWTA to recruit reports as needed (can anyone get to Lighthouse Park? We haven't seen a report in years!) and hear from a variety of perspectives regarding campsite conditions. Perhaps the greatest benefit of the revised Site Steward Program – no more waiting list!

You can join the ranks of trained Site Stewards by attending the next training Saturday, May 2 (location TBA). The free Site Steward training covers the basics of observing and reporting site conditions, identifying invasive species, working with land managers, and low-impact recreation skills. ## Marine Shoreline Public Access Portal

The Department of Ecology's online Washington Coastal Atlas, known for its aerial shoreline photos, will soon feature more information useful for the public. Deborah Purce, a NOAA Coastal Management Fellow from Western Washington University, is developing a public access portion for the Atlas. She envisions the Atlas as a portal for positive experience and education at saltwater edge. The two-year fellowship ends mid-2010.

There are already updates. In addition to the GIS-based viewer's 2006 marine shore photos of Puget Sound and the outer coast, it now has aerial photos taken in 2007 for the Columbia, Snake and other major water bodies, including Lake Chelan in eastern Washington and the lakes of the Lakes-To-Locks Water Trail. Ecologists can view land cover, habitat types, drift cells, eelgrass, kelp, and shellfish

areas. Those interested in development history can view photos from the 1940's, '70's, '90's, and 2002.

Purce is working on an Atlas redesign to include a point and click public access database and improved links. Background imagery can be selected for viewing: satellite imagery, hillshade, USGS topos, and soon, NOAA nautical charts. This useful planning tool will only improve over the next year and a half. The Coastal Management Fellowship was established in 1996 to provide on-the-job education and training opportunities in coastal resource management and policy for postgraduate students and to provide project assistance to state coastal zone management programs.

## Budget Proposal Threatens to Close Four Cascadia Marine Trail Sites

Last spring, a dozen WWTa volunteers relocated a Cascadia Marine Trail Site that was sloughing into the sea at Kopachuck State Park. The afternoon was spent pulling weeds, installing signs, and grubbing campsites. As the work party ended, a local boy scout troop arrived to take measurements for a new kayak rack they would later install. The new Kopachuck Cascadia Marine Trail is high above the eroding effects of the waves, but now the park and campsite are threatened by shortfalls in the state budget.

Governor Gregoire's proposed 2009-11 budget reflects the critical state of the national economy. Services and spending are being cut across the board, including funding for parks and recreation. The Washington State Parks and Recreation Commission budget proposal for the next biennium, which begins July 1, aims for a \$10 million reduction. This budget cut includes reductions in equipment replacement, closure of the Puget Sound Region office, limiting of services, and a move to "mothball" or close 15 parks and expand seasonal park closures.

State Parks will close and seek other public owner-operators for 13 parks deemed by the Commission as "not consistent" with the Centennial 2013 Vision (premier destinations or places of regional or statewide significance). Among the park closures are four key Cascadia Marine Trail Sites: Kopachuck, Fay Bainbridge, Joemma

Beach, and Fort Ward. In addition, a new site was planned for Old Fort Townsend, another park slated for closure. If the budget cuts are approved, the parks may be closed or turned over to new owners by September 15<sup>th</sup>, 2009.

Closure of these Cascadia Marine Trail Sites would reverse years of progress on the water trail and leave gaping holes for long-distance paddlers. State Parks is making an effort to find new operators for the parks, such as local county park departments, but local agencies are feeling the budget crunch as well. Ideally, the parks will remain in the hands of State Parks, a long-time partner and proponent of the Cascadia Marine Trail. If the ownership of these important sites changes, however, WWTa will advocate to keep the Cascadia Marine Trail Sites open and available for overnight use by non-motorized boaters.

Your local representatives will be charged with making final determinations about the state budget. Please consider calling or writing a letter of support for Puget Sound's precious State Parks. Call Washington's Legislative Hotline at 800.562.6000 to leave a brief message that will be passed along to the three legislators from your district - it takes only a couple minutes!
